BY-LAW NO. 27-00

A BY-LAW OF THE MUNICIPALITY OF GRAND MANAN RESPECTING THE COMPOSITION OF THE COUNCIL AND THE REMUNERATION OF THE MAYOR AND COUNCILLORS

THE COUNCIL OF THE MUNICIPALITY OF GRAND MANAN DULY ASSEMBLED HEREBY ENACTS AS FOLLOWS:

COMPOSITION

- 1. The Council consists of
 - (a) a Mayor, and
 - (b) nine Councillors (one from each of the five wards and four from at large).

REMUNERATION

- 2. (1) The Remuneration of the Mayor shall be as follows:
 - (a) An Honorarium of \$4,000.00 (four thousand) dollars per year, payable quarterly, provided that the Mayor attends 10 (ten) of the 12 (twelve) regular Council meetings held yearly. In the event that the Mayor is absent from more than 2 (two) of the 12 (twelve) regular Council meetings yearly, the Clerk shall prorate his Honorarium according to the percentage of the regular meetings he does attend, and
 - (b) An Extra Meeting Fee Allowance of \$100.00 (one hundred) dollars per meeting, payable quarterly, to a maximum of 24 (twenty-four) meetings over and above the regular meetings per year.
 - (c) One third of the Mayor-s Honorarium or \$1,333.33 (thirteen hundred thirty-three point thirty-three) dollars shall be classed as a non-taxable expense allowance for duties performed in and around the Village area, as well as for attending 10 (ten) Regular Council meetings per year.
 - (d) One third of the Mayors Extra Meeting Fee Allowance per meeting or \$33.33 (thirty-three point thirty-three) dollars shall be classed as a non-taxable expense allowance for travel expenses to the meeting.
 - (2) The Remuneration of the Deputy Mayor shall be as follows:
 - (a) An Honorarium of \$2,500.00 (twenty-five hundred) dollars per year, payable quarterly, provided that the Deputy Mayor attends 10 (ten) of the 12 (twelve) Regular Council meetings held yearly. In the event that the Deputy Mayor is absent from more than 2 (two) of the 12 (twelve) Regular Council meetings yearly, the Clerk shall prorate his Honorarium according to the percentage of the regular meetings he does attend, and
 - (b) An Extra Meeting Fee Allowance of \$50.00 (fifty) dollars per meeting, payable quarterly, to a maximum of 24 (twenty-four) meetings over and above the Regular meetings per year.

- (c) One third of the Deputy Mayors Honorarium or \$833.33 (eight hundred thirty-three point thirty-three) dollars shall be classed as a non-taxable expense allowance for duties performed in and around the Village area, as well as for attending 10 (ten) Regular Council meetings per year.
- (d) One third of the Deputy Mayor-s Extra Meeting Fee Allowance per meeting or \$16.67 (sixteen point sixty-seven) dollars shall be classed as a non-taxable expense allowance for travel expenses to the meeting.
- (3) The Remuneration of each Councillor shall be as follows:
 - (a) An honorarium of \$1,500.00 (fifteen hundred) dollars per year, payable quarterly, provided that the Councillor attends 10 (ten) of the 12 (twelve) regular Council meetings held yearly. In the event that the Councillor is absent from more than 2 (two) of the 12 (twelve) regular Council meetings yearly, the Clerk shall prorate his Honorarium according to the percentage of meetings he does attend, and
 - (b) An Extra Meeting Fee Allowance of \$50.00 (fifty) dollars per meeting, payable quarterly, to a maximum of 24 (twenty-four) meetings over and above the regular meetings per year.
 - (c) One third of the Councillor-s Honorarium or \$500.00 (five hundred) dollars shall be classed as a non-taxable expense allowance for duties performed in and around the Village area, as well as for attending 10 (ten) Regular Council meetings per year.
 - (d) One third of the Councillor's Extra Meeting Allowance per meeting or \$16.67 (sixteen point sixty-seven) dollars shall be classed as a non-taxable expense allowance for travel expenses to the meeting.
- 3. Bylaw No. 7-96, a Bylaw of the Village Of Grand Manan respecting the Composition of the Council and the Remuneration of the Mayor and Councillors, is hereby repealed.
- 4. This by-law comes into force on the Fourteenth day of Mayo 2001.
