## VILLAGE OF GRAND MANAN BY-LAW NO. 41-05

A By-Law Respecting The Stopping Up and Closing Of a Highway At Ingalls Head In the Village of Grand Manan

**Whereas** the Council of the Village of Grand Manan has the authority under Section 187 of the Municipalities Act to stop up a highway; and

Whereas it is determination of the Council of the Village of Grand Manan that the portion of the highway located at Ingalls Head is not required by the public for use;

**It is hereby enacted** as a By-Law of the Village of Grand Manan that the portion of highway no longer used and described as follows:

**ALL** that certain parcel of land, situated at Ingalls Head, Village of Grand Manan, County of Charlotte, Province of New Brunswick, shown as Parcel 2003-02 on Public Works and Government Services Canada Plan S-4879, dated December 1, 2003, signed by Robert A.G. Fulton, New Brunswick Land Surveyor and said Parcel 2003-02 being more particularly described as follows:

**BEGINNING** at a survey marker (627) situated on a northerly limit of the Ingalls Head Road, as shown on the above mentioned plan, said survey marker (627) having New-Brunswick Grid Coordinate Values of East 2 479 534.907 metres and North 7 295 977.864 metres;

**THENCE** 76° 25' 30" a distance of 52.78 metres to a survey marker (146);

**THENCE** continuing 76° 25' 30" a distance of 6.71 metres to a calculated point (147) situated on the ordinary high water mark (1988) of the Bay of Fundy;

**THENCE** following the said ordinary high water mark of the Bay of Fundy, in a generally southeasterly direction, a distance of 23.3 metres, more or less to a calculated point (1000), said calculated point (1000) being 141° 45' 30" a distance of 22.43 metres from the last mentioned calculated point (147);

**THENCE** 256° 29' 20" a distance of 6.20 metres to a survey marker (1001);

**THENCE** continuing 256° 29' 20" a distance of 25.44 metres to a survey marker (629) situated on the said northerly limit of Ingalls Head Road, as shown on the above mentioned plan;

**THENCE** following the said northerly limit of Ingalls Head Road, and along the arc of a curve to the left, having a radius of 44.207 metres, for an arc distance of 44.24 metres to

the Place of Beginning, said Place of Beginning being  $105^{\circ} 05' 50''$  a distance of 42.42 metres from the last mentioned survey marker (629);

**THE** above described Parcel 2003-02 contains an area of 807 square metres, more or less.

**ALL** azimuths, distances and coordinates are grid, referenced to the New Brunswick Double Stereographic Projection System, NAD83 (CSRS adjusted values).

Is hereby stopped up and closed and all rights of the public to traverse the same are discontinued.
