BY-LAW NO. 42-06

A BY-LAW TO STOP UP, ABANDON AND CLOSE A PORTION OF THE SHORE ROAD, SO-CALLED

BE IT ENACTED by the Council of the Village of and Manan, as follows:

All that portion of the "Shore Road", so-called, more particularly described as follows:

That portion of the "Shore Road", so-called which road was laid out as a road by Wilford Fisher William Gatcomb and Philip Newton being Commissioners of Highways received and registered 2nd September, 1831 having become known as the Shore Road at the Village of Grand Manan, Parish of Grand Manan, County of Charlotte, Province of New Brunswick.

Said portion of laid out road having its centerline intersect the southern side of NB Route 776 near the northeast corner of Lot 89-1 as shown on a plan filed in the Charlotte County Registry as Plan # 4488.

Thence in an easterly direction from the aforementioned southern side of Route 776, a distance of 170 metres, more or less, to the western side of M & G Fisheries Ltd. property being shown as Parcel "A" on Plan # 4029. Said laid out road having a width of 3 Rods (49 ½). Intending to be the portion crossing the Phillip and Doris Ells property at Grand Harbour, Village of Grand Manan.

is hereby permanently stopped up, abandoned and closed and shall no longer be a public thoroughfare.

We hereby certify to all whom it may concern that we have by and with the consent of the owners and occupiers of that land over which the same does pass laid out a public highway and wish it to be established and recorded such beginning at the South Westerly corner of land owned Wilford Fisher at a Ceder just at the corner of his said Fisher's store wall extending thence its width westerly, the same bound being at Woodwards Cove (so called), the said road thence running South westerly on and in front of lands granted to Jack Ingersoll, and from thence continuing south westerly until it strikes the Mill Brook (so called) thence along said Brook on its Western bank to its mouth in the Grand Harbour and there forming an angle in front of the house occupied by Samuel Cheney and from thence running westerly in a straight line by and in front of the house occupied by the widow Burk and from thence continuing the same straight line Westward of the barns owned and occupied by John Ingalls and Olive Wooster until the same by such straight line being extended shall strike the now present highway near the Church Bridge and that laid Road by three rods wide and that the same has been done by us in the Parish of Grand Manan, County of Charlotte, this 25th day of June, 1831.

Thence in an easterly direction from the aforementioned southern side of Route 776, a distance of 170 metres more or less to the western side of M&G Fisheries Ltd. property being shown as Parcel "A" **on Plan** # 4029. Said laid out road having a width of 3 Roth (49 %2). Intending to be the portion crossing the Phillip and Doris Bib property at Grand Harbour, Village of Grand Manan.
